## NOTICE: TO ALL IMPORTERS OF DAIRY PRODUCTS

Effective: 1<sup>st</sup> January 2006

### REGISTRATION FOR IMPORTS

- 1.0 **Registration:** Importers of all Dairy Board's scheduled products will pay a registration fee of E50-00 per annum
- 2.0 **Import Permit:** E10-00 valid for 30 days.
- 3.0 **Transit Permit:** E250 valid for 1 month.
- 4.0 **Emergency Permit:** E200-00 for single entry permit.
- 5.0 **Export Permit:** E50-00 valid for 30 days.
- 6.0 **Escort Fee:** E250-00.
- 7.0 **Surcharge For Not Returning a Permit In Time:** After the expiry date of a permit a fee of E20-00 per month will be charged for late Returned Permit
- 8.0 **Penalty:** The penalty for non/under-declaration of goods at the border will be 40% of the real value of goods plus normal Dairy Board levy.
- 9.0 **Lost Permit:**
  - 9.1 An importer who has lost a permit will be charged a penalty fee ranging from E1, 500-00 to E20, 000-00.
  - 9.2 A search fee of E100-00 will be charged for a lost Customs CCA1 form or permit. An official of the Inspectorate Department will take his/her time to search for Customs forms/permits at the Customs and Excise Department Offices.
  - 9.3 If upon searching Customs Forms:
    - a) Are found; an importer will then pay the necessary Board levy.
    - b) Are not found; a penalty fee in item 9.1 will apply.
  - 9.4 If an importer repeatedly loses permits/customs forms, issuing of permits will be stopped.

**NOTE:** It is the Dairy Board's statutory requirement that every permit issued must be returned to the Board after one month, used or unused, for proper up keep of the Board's records.
